Introductions

Steering Committee attendees took roll call.

Mr. Ruff addressed the group with a comments concerning the amount of effort that has been undertaken for economic development within the Northern Lehigh region. He provided an opportunity to discuss the importance of attracting the right type of development and questioned how the comprehensive plan could assist in efforts. The Committee members discussed previous efforts in management of the region and it was noted that this would be an important aspect of the comprehensive plan.

Issues & Opportunities Review

Mr. Doyle provided an update on staff progress towards producing an Issues and Opportunities paper. He indicated the report would ultimately provide guidance toward a collective consensus of goals and objectives for the Comprehensive Plan. The group briefly discussed the importance of data already collected and identified outstanding needs for the Issues and Opportunities paper. The group also discussed the data that was presented throughout the planning process during public outreach events and identified needs from various Steering Committee meetings.

Mr. Ruff introduced the concept of revitalization for Slatington and discussed the opportunities for redevelopment of its downtown. The group discussed different approaches to guiding interest into the region while maintaining its character and ensuring the development capitalizes on the recreational and agricultural assets of the communities.
